The Pike County Commission met in a regular session on March 22, 2021 at 5:15 P.M. in the main auditorium of the Pike County Courthouse Annex – Pike County Health Department Building at which time the following members were present: Chairman Robin Sullivan, Commissioners Homer Wright, Jimmy Barron, Chad Copeland, Cynthia S. Pearson, and Russell Johnson.

Commissioner Barron made a motion to approve the minutes of the regular meeting of March 8, 2021 as presented. Commissioner Wright seconded the motion and all voted yea.

Commissioner Johnson made a motion to approve the claims as presented. Commissioner Copeland seconded the motion and all voted yea.

Commissioner Barron made a motion to approve the promotion of Travis Jacques to a Full-time Engineering Aide II at a Grade 8A, Step I, effective March 24, 2021. Commissioner Johnson seconded the motion and all voted yea.

Commissioner Copeland made a motion to advertise for an Equipment Operator I or II to fill a vacancy after Ronald Bundy filed for retirement. Commissioner Wright seconded the motion and all voted yea.

Commissioner Copeland made a motion to approve the County Engineer’s request to adopt Resolution 21-0322A and approve an agreement with the State of Alabama relating to a bridge scour repair on County Road 3316, .15 miles East of County Road 3314; FHWA Disaster# AL 2020-02; Project# ERPR-9072; CPMS Ref# 100073431 and 100073494. Commissioner Johnson seconded the motion and all voted yea.

Commissioner Copeland made a motion to approve the County Engineer’s request to adopt Resolution 21-0322B and approve an agreement with the State of Alabama relating to a culver replacement due to severe scour damage on County Road 6618, .858 miles southwest of U.S. Highway 29; FHWA Disaster# A: 2020-02; Project# ERPR-9072; CPMS Ref# 100073432 and 100073493. Commissioner Johnson seconded the motion and all voted yea.
