The Pike County Commission met in a regular session on July 14, 2025 at 5:15 P.M. in the main auditorium of the Pike County Courthouse Annex – Pike County Health Department Building at which time the following members were present: Chairman Chad Copeland, Commissioners Lawanda Green-Bell, Robin Sullivan, Jimmy Barron, Cynthia Pearson, and Russell Johnson.

Commissioner Barron made a motion to approve the June 23, 2025, meeting minutes, as presented. Commissioner Pearson seconded the motion and all voted yea.

Commissioner Sullivan made a motion to approve the claims, as presented. Commissioner Johnson seconded the motion and all voted yea.

Commissioner Johnson made a motion to approve Resolution 2025-0714A awarding the professional services for the PY 2025 Community Development Block Grant application to Southern Engineering Solutions. Commissioner Sullivan seconded the motion and all voted yea.

Commissioner Johnson made a motion to approve Resolution 2025-0714 authorizing to execute and submit an application for the 2025 Community Development Block Grant funds in the amount of \$500,000, with a local share of \$57,750. Commissioner Sullivan seconded the motion and all voted yea.

Commissioner Pearson made a motion to approve Resolution 2025-0714B to designate a public officer to carry out the directives of the Open Records Act, as amended by Act No. 2024-278, as they pertain to public records in the custody and control of the Commission and to develop and recommend to the Commission the adoption of procedures for accepting Public Records Requests. Commissioner Johnson seconded the motion and all voted yea.

Commissioner Pearson made a motion to approve Resolution 2024-0714C to designate the Pike County Administrator to serve as the Public Officer of Pike County to carry out the directives of the Open Records Act, as amended by Act No. 2024-278, as they pertain to public records in the custody and control of the Commission and to develop and recommend to the Commission from time-to-time the adoption of procedures for accepting Public Records Requests. Commissioner Sullivan seconded the motion and all voted yea.

Commissioner Pearson made a motion to appoint Kenneth Duncan to the Pike County 911 Board. Commissioner Green-Bell seconded the motion and all voted yea.

Commissioner Barron made a motion to adjourn the meeting. Commissioner Sullivan seconded the motion and all voted yea.
