The Pike County Commission met in a regular session on October 27, 2025 at 5:15 P.M. in the main auditorium of the Pike County Courthouse Annex – Pike County Health Department Building at which time the following members were present: Chairman Chad Copeland, Commissioners Lawanda Green-Bell, Robin Sullivan, Jimmy Barron, Cynthia Pearson, and Russell Johnson.

Commissioner Barron made a motion to approve the September 22, 2025 meeting minutes, as presented. Commissioner Pearson seconded the motion and all voted yea.

Commissioner Sullivan made a motion to approve the claims, as presented. Commissioner Johnson seconded the motion and all voted yea.

Commissioner Johnson made a motion to approve the Solid Waste exemptions, as presented. Commissioner Green-Bell seconded the motion and all voted yea.

Commissioner Sullivan made a motion to suspend the rules to allow for a vote on approving easements for the City of Troy for property located at the Pike County Health Department, two Tracer SC update agreements with Trane U.S. Inc. for the Courthouse and Health Department, an agreement with Guardian Pro for Jail Safety Software, an FMLA request for the Jail, an RFQ for grant writing and grant administration services, and a reappraisal budget revision. Commission Sullivan made a motion to approve a temporary construction easement, a permanent and perpetual utility easement, and a permanent and perpetual drainage easement for the City of Troy for property located at the Pike County Health Department. Commissioner Johnson seconded the motion and all voted yea.

Commissioner Pearson made a motion approve Tracer SC Update Agreements for the Courthouse and Health Department with Trane U.S. Inc., in the amount of \$4,650.00 each. Commissioner Sullivan seconded the motion and all voted yea.

Commissioner Johnson made a motion to approve a Public Safety Software Agreement with Guardian RFID for up to six years of service and to be paid for out of the Inmate Housing Fund. Commissioner Sullivan seconded the motion and all voted yea.

Commissioner Pearson made a motion to approve a Family Medical Leave Act request for Shawann Rogers, due to the birth of her child. Commissioner Green-Bell seconded the motion and all voted yea.

Commissioner Johnson made a motion to advertise for requests for qualification for grant writing and grant administration services. Commissioner Green-Bell seconded the motion and all voted yea.

Commissioner Sullivan made a motion to approve the County Administrator's request to approve a budget revision for Reappraisal, as presented. Commissioner Pearson seconded the motion and all voted yea.

Commissioner Johnson made a motion to deny the Infinity Café and Lounge 010- Lounge Retail Liquor License- Class I. Commissioner Sullivan seconded the motion. Commissioners Sullivan, Barron, Copeland, and Johnson voted yea, and Commissioners Green-Bell and Pearson abstained.

Commissioner Sullivan made a motion to approve the County Administrator's request to approve Resolution 2025-1027 amending Resolution 17-0213, which established limits on the use of credit cards to the sum of \$10,000 per purchase and limiting (2) to the sum of \$16,000 for all purchases that may be made per month. Commissioner Johnson seconded the motion and all voted yea.
