The Pike County Commission met in a regular session on January 24, 2022 at 5:15 P.M. in the main auditorium of the Pike County Courthouse Annex – Pike County Health Department Building at which time the following members were present: Chairman Robin Sullivan, Commissioners Homer Wright, Jimmy Barron, Chad Copeland, and Cynthia S. Pearson. Commissioner Russell Johnson was absent.

Commissioner Barron made a motion to approve the minutes of the regular meeting of December 13, 2021, as presented. Commissioner Pearson seconded the motion and all voted yea.
