The Pike County Commission met in a regular session on April 11, 2022, at 5:15 P.M. in the main auditorium of the Pike County Courthouse Annex – Pike County Health Department Building at which time the following members were present: Chairman Robin Sullivan, Commissioners Homer Wright, Jimmy Barron, Chad Copeland, Cynthia S. Pearson, and Russell Johnson.

Commissioner Barron made a motion to approve the minutes of the regular meeting of March 28, 2022, as presented. Commissioner Wright seconded the motion and all voted yea.

Commissioner Johnson made a motion to approve the claims as presented. Commissioner Pearson seconded the motion and all voted yea.

Commissioner Barron made a motion to approve the County Engineer’s request to hire Johnny Ray Ousley as a full-time Operator II at a Grade D, Step 2, effective April 13, 2022. Commissioner Wright seconded the motion and all voted yea.

Commissioner Johnson made a motion to suspend the rules to allow for a vote on declaring surplus property in the Sheriff’s Department, closing the Troy Bank & Trust CDBG/EDA checking account, and an FMLA request for employee, Joniece Johnson.
