Commissioner Copeland made a motion to approve the minutes of the regular meeting of August 8, 2022, as presented. Commissioner Wright seconded the motion and all voted yea.

Commissioner Johnson made a motion to approve the claims as presented. Commissioner Wright seconded the motion and all voted yea.

Commissioner Copeland made a motion to approve the Probate Judge's request to advertise for a Probate Customer Service Representative I and a License Inspector. Commissioner Johnson seconded the motion and all voted yea.

Commissioner Copeland made a motion to approve the School Resource Officer Agreement with the Pike County Board of Education for an annual sum of \$140,000, with an expiration date of September 30, 2023. Commissioner Wright seconded the motion and all voted yea.

Commissioner Johnson made a motion to approve Resolution 2022-0822A supporting CRC of Alabama, LLC's efforts to establish and operate a medical cannabis business in Pike County. Commissioner Wright seconded the motion and all voted yea.

Commissioner Copeland made a motion to approve the Revenue Commissioner's request to contract with Dennis Rogers for mapping services in the Reappraisal Department at \$34,000 per year to be paid in monthly installments from Reappraisal Funds. Commissioner Johnson seconded the motion and all voted yea.

Commissioner Wright made a motion to close the Dealer Plate checking account and transfer the remaining funds to the General Fund. Commissioner Johnson seconded the motion and all voted yea.
