The Pike County Commission met in a regular session on March 13, 2023, at 5:15 P.M. in the main auditorium of the Pike County Courthouse Annex – Pike County Health Department Building at which time the following members were present: Chairman Robin Sullivan, Commissioners Homer Wright, Jimmy Barron, Chad Copeland, Cynthia S. Pearson, and Russell Johnson.

Commissioner Barron made a motion to approve the minutes of the regular meeting of February 27, 2023, as presented. Commissioner Pearson seconded the motion and all voted yea.

Commissioner Wright made a motion to approve the claims as presented. Commissioner Johnson seconded the motion and all voted yea.

Commissioner Copeland made a motion to suspend the rules to allow for a vote on opening a Pistol Permit Grant Fund and an Opioid Settlement Fund checking account and to approve the Revenue Commissioner’s request to surplus a Ford Explorer.
