The Pike County Commission met in a regular session on December 8, 2025 at 5:15 P.M. in the main auditorium of the Pike County Courthouse Annex – Pike County Health Department Building at which time the following members were present: Chairman Chad Copeland, Commissioners Lawanda Green Bell, Robin Sullivan, Jimmy Barron, Cynthia Pearson, and Russell Johnson.

Commissioner Barron made a motion to approve the November 24, 2025 meeting minutes, as presented. Commissioner Johnson seconded the motion and all voted yea.

Commissioner Pearson made a motion to approve the claims, as presented. Commissioner Sullivan seconded the motion and all voted yea.

Commissioner Johnson made a motion to approve the Solid Waste exemptions, as presented, to include the renewal of three existing exemptions. Commissioner Green Bell seconded the motion and all voted yea.

Commissioner Sullivan made a motion to suspend the rules to allow for a vote on a five-year Hazard Mitigation Plan with ten counties, an agreement with Gibson & Carden for the financial statement preparation, to accept a resignation from Johnny Turvin from his position as Deputy Coroner, and to approve a Family Medical Leave Act request from Brayton Hughes. Commission Sullivan made a motion to approve the County EMA Director's request to approve a five-year Hazard Mitigation Plan with ten counties. Commissioner Johnson seconded the motion and all voted yea.

Commissioner Pearson made a motion to approve an agreement with Gibson & Carden, LLC to prepare the financial statements for the 2024-2025 fiscal year, not to exceed \$8,500. Commissioner Johnson seconded the motion and all voted yea.

Commissioner Sullivan made a motion to accept the resignation of Johnny Turvin from his position as Deputy Coroner. Commissioner Johnson seconded the motion and all voted yea.

Commissioner Johnson made a motion to approve the Family Medical Leave Act request from Brayton Hughes, due to the birth of a child. Commissioner Sullivan seconded the motion and all voted yea.

Commissioner Barron made a motion to approve the Sheriff Department's vehicle bid award of six full-size Sport Utility Vehicle Police Pursuit Vehicles to Donohoo Chevrolet in the amount of \$50,900 per unit. Commissioner Green Bell seconded the motion and all voted yea.

Commissioner Johnson made a motion to approve Kenneth Duncan and Jimmy Barron to the E911 Board for a four-year term. Commissioner Sullivan seconded the motion and all voted yea.

Commissioner Sullivan made a motion to cancel the next scheduled Commission Meeting on December 22, 2025, due to the Christmas holiday. The next scheduled Commission Meeting will now be on January 12, 2026. Commissioner Johnson seconded the motion and all voted yea.

Commissioner Barron made a motion to adjourn the meeting. Commissioner Sullivan seconded the motion and all voted yea.
